

CONSENT FORM AND TERMS OF USE FOR SERVICES OF VFS GLOBAL

I, _____, as a user of VFS GLOBAL services hereby understand and agree that:

I have read all the terms and conditions, rules and regulations applicable for attending FIFA World Cup 2018 and procuring the FAN ID for the same completely. I am availing the services of VFS GLOBAL to enable me to procure my FAN ID, as per the applicable terms and conditions.

I hereby consent to VFS GLOBAL receiving my personal information/data, which I have provided at the time of registration of my FAN ID on the following website <https://www.fan-id.ru/index.html>

My personal information may also include identity and contact information necessary to provide the service and may in some instances, include but shall not be limited to the electronic records or data as required by VFS Global or other documents whatsoever that I have provided at the time of my registration on the website as mentioned herein related to my FAN ID registration.

I hence have no objection and consent to VFS GLOBAL collecting, storing, holding, using, disclosing and retaining all my personal information/data for the purposes of delivering my FAN ID required for participating in FIFA World Cup 2018.

I am aware that it is advisable that the FAN ID must be received by me in person only. However I consent that due to any reason whatsoever if I am not able to collect my FAN ID in person, then I shall authorize any of my representative to collect the said FAN ID by providing an original notarized power of attorney (POA) in favour of the said representative to enable him/her to collect/receive FAN ID on my behalf from VFS Global. VFS GLOBAL thus shall not be liable for failure on my part to collect/ receive my FAN ID in person for any reason whatsoever and nor I shall claim any kind of damages, losses etc. arising out of it for the same.

While receiving the FAN ID either in person or via courier or via my authorized representative, I agree that for verification purpose I must provide an identification proof wherein my name mentioned therein must match with the name registered for the FAN ID. FAN ID will not be handed over to me or to my authorized representative by VFS GLOBAL under any circumstances if the identification proof cannot be verified for any reason whatsoever. I understand and agree that, it is entirely my obligation to ensure that the correct identification proof is provided by me to the VFS. VFS shall not be under any circumstances held responsible / liable if I fail to comply with any of the mandates as essential.

In case of the courier service if the FAN ID is not delivered and returned by the courier vendor to VFS GLOBAL for any reason whatsoever, including but not limited to failure to provide identification proof, having missed the courier due to me not being available to receive the FAN ID on its arrival, etc. In such an event, the said courier services shall be deemed to be rendered by VFS GLOBAL. I am also aware that for another courier delivery attempt of my FAN ID by VFS GLOBAL, I must again submit a fresh courier application to VFS GLOBAL along with the requisite service fee.
